- 2024 Maximum Donation Amounts:

- Married filing jointly: \$2,910
- Filing single: \$1,459

*Donations can be made through April 15th, 2025 for the 2024 tax year.*

- 2025 Maximum Donation Amounts:

- Married filing jointly: \$3,062
- Filing single: \$1,535

- Donations are claimed on forms 323 and 348.
