The software will automatically split your donation between forms 323 and 348. Unless you are carrying credits forward from a previous year, this information should match your receipt from us.

You will see the following message:

Maximum Credit

Your maximum available credit for contributions to private school tuition organizations (Form 323) made during 2024 is limited to \$1,459.

You have an additional credit of up to \$1,451 on Form 348 if your donation exceeds the limit for Form 323.

We've calculated an additional available credit of \$1,451. There is nothing more you need to do.

These credits will only reduce your tax to zero. If you don't need these credits in 2024, they will carryover to next year for up to five years from when you made your original donation.

Once completed, information from forms 323 and 348 are automatically added to form 301 along with any of your other Arizona Tax Credits you have made, and finally, be listed on your state tax form.

TIPS FOR CLAIMING





A SCHOOL TUITION ORGANIZATION CANNOT AWARD, RESTRICT OR RESERVE SCHOLARSHIPS SOLELY ON THE BASIS OF A DONOR'S RECOMMENDATION. A TAXPAYER MAY NOT CLAIM A TAX CREDIT IF THE TAXPAYER AGREES TO SWAP DONATIONS WITH ANOTHER TAXPAYER TO BENEFIT EITHER TAXPAYERS OWN DEPENDENT.

Step 1. Determine how much you would like to donate.

You can donate your tax liability, or the maximum set by the state. The maximums set by the state for the 2024 tax year are \$2,910 if you are married filing jointly, and \$1,459 if you are filing single.

If you are uncertain of your tax liability, one option is to estimate your liability by looking at last year's tax form. Another option is to complete your taxes on TurboTax without making the donation (to see what your liability is), then rework TurboTax to reflect your donation.

Remember, your tax liability is not what you owe when you file your taxes, but is the total amount of taxes you pay the state for the year. Your tax liability will show on the summary provided by TurboTax.
